1. To confirm the minutes of the Executive Committee meeting held at **Chandigarh** on 17<sup>th</sup> & 18<sup>th</sup> November, 2025.
2. To place an action taken report vis-a-vis the decisions of the EC to relaunch agitation and go on Full Day Strike in pursuance of demands.
3. To take stock of the approach and attitude of the management on our demand for adequate recruitment of Clerks, (Customer Service Associates) and filling up of sanctioned posts of Office Assistants, Housekeepers and Armed Guards and consider further course of actions.
4. To take stock of the developments on the complaint that was filed before the Chief Labour Commissioner (Central), New Delhi on the issues arising out of and connected with the system of engagement of casual/ daily rated workers in the bank and decide on further course of action.
5. To take stock of the status of all unresolved issues/ unaddressed concerns/ unredressed grievances (including demands raised in the Notices of Strike dated 13 March, 2026) and consider further steps, if the need is felt, to get them resolved/ settled/ addressed as soon as possible.
6. To take stock of compliance of the decisions taken for making affiliates constitutionally and statutorily compliant to obviate organizational complications/ disputes/ litigation etc and consider corrective actions, if required. Further, to discuss, deliberate and take a call on the issues arising out of and connected with the organization.
7. To discuss and analyse business financials of FY 2025-26 of the bank and frame our response thereto.
8. To take stock of the working of “Centralised Disciplinary Authority Division” at Bank’s HO and take stock of working of “Vigilance Wing” of the bank, its approach and attitude in investigating and attributing lapses outside “Area of Work” and also the approach of the Disciplinary Authority in framing charges outside the ambit of acts of omission and/or commission as enumerated in BPS dated 10. 04. 2002 (and as up-to-date) and in classifying so-called lapses as misconduct and frame our response thereto.
